What is happening?

The <u>draft budget proposals from the WA state House and Senate</u> slash funding for WWU and other 4-year colleges and universities. They could cut between \$8 and \$9 million in state support and, in combination with our local fiscal problems, **WWU could face roughly up to \$14 million in cuts**.

In the coming weeks, the legislature will work on reconciling these budgets to eventually go to Governor Ferguson's desk. We have **a small window** now to <u>let our legislators</u> and budget writers know that these kinds of cuts to WWU would cause irreparable, generational harm the WA community and beyond.

What can I do?

We're so glad you asked! Reaching out to legislators and budget writers is essential in the next few weeks. Hearing about the direct, on-the-ground impacts of these budget decisions is the most potent way individuals can contribute the broader work of our labor organizations to push for funding for public higher ed at a time when our mission and constituents are being attacked.

What should I say?

Share your name and what you teach.

The best thing you can do is speak directly to how such cuts would impact you and your students. Think practically about what a 3-15% cut to your daily resources might look like and talk about that impact.

This messaging is most effective when it's personal, rooted in your experience and expertise.

What is the goal?

To put pressure on legislators from their constituents to stand up for funding public higher education in a time when it's under attack on the national stage.

To give legislators particular stories, examples, and reasons why supporting this funding and rejecting cuts is essential to the broader health and vision for the state of Washington.

Some Suggested Talking Points

- In its constitution, WA identifies education as the "paramount duty" of the state. This should include public higher education. K-12, technical and community colleges, and public 4-year universities are part of an interrelated ecosystem, not individual parts that can be separated.
- WWU already receives the least state funding per student of any higher ed institution in the state, including tech and community colleges. Despite this, we have high enrollment and excellent retention and graduation rates.
- Public higher education not only provides low-barrier high-quality education to students but also contributes to communities more broadly. Many of our students stay in WA and go into the public sector.
- At a time when higher education is under attack at the federal level, our state leaders should be supporting our work.
